LawNet is an Internet Division of **Percetakan Nasional Malaysia Berhad (PNMB)**. It provides an Online Library of Malaysian Laws which is accessible via Pustaka's website. It consists of :

- i). **Law Library** which contains the AUTHORITATIVE text of the laws of Malaysia i.e. Updated Acts of Parliament, Principal Acts (Original), Amendment Acts, Ordinances, Bills Supplement, Updated rules and Regulations, Legislative Supplement (A), Legislative supplement (B), Federal Constitution, Criminal Procedure Code, Penal Code, National Land Code, Rules of Court, Court Forms, General Orders and "Arahan Perbendaharaan".
- ii). **E-Gazette** is the electronic version of Malaysia Gazette printed by PNMB, the official printer appointed by the Government of Malaysia. The E-Gazette is available on-line as soon as it is published weekly. It currently contains – Federal Gazettes – Principal Acts, Amending ActsBills Supplement, (B) and Gazette Notification (GN).  
**State Gazettes** – State Legislations for Selangor, Pahang, Negeri Sembilan, Malacca, Johor, Terengganu, Perak, Penang, Perlis, Kedah, Kelantan and Sarawak.
- iii). **Istilah Undang-Undang (English – B. Malaysia)** – which contains more than 30,000 words, terms and phrases commonly used by legal practitioners, lawyers, Government officers, students and those who are constantly in touch with the laws. It is an invaluable tool and would be extremely useful for people doing translation work.
- iv). **Latin Dictionary** – consists of more than 5,000 words. It is compiled from various sources and by no means conclusive.
- v). **Judgments** – contains selected *Privy Council Judgements*.
- vi). **Index of Subsidiary Legislations** – a complete list of Legislative Supplement (A) [**P.U.(A)**] and Legislative Supplement (B) [**P.U.(B)**].

The information in the database is comprehensive and easy to use for practicing lawyers, legal advisors, academicians, law students as well as people who have a daily need to refer to Malaysian laws. However, please be reminded that this database is subscribed based on a *single license-only*, thus only one individual can access at any one time.

Lawnet adalah Bahagian Internet **Percetakan Nasional Malaysia Berhad (PNMB)**. Ia menyediakan *Online Library of Malaysian Laws* seperti di bawah:

- i). **Law Library** mengandungi teks BERWIBAWA undang-uandang Malaysia i.e *Updated Acts of Parliament, Principal Acts (Original), Amendment Acts, Ordinances, Bills Supplement, Updated rules and Regulations, Legislative Supplement (A), Legislative supplement (B), Federal Constitution, Criminal Procedure Code, Penal Code, National Land Code, Rules of Court, Court Forms, General Orders and “Arahan Perbendaharaan”.*
- ii). **E-Gazette** merupakan versi elektronik bagi Malaysia Gazette cetakan PNMB, pencetak rasmi yang dilantik oleh Kerajaan Malaysia. E-Gazette boleh didapati secara dalam talian sebaik sahaja ianya diterbitkan setiap minggu. Ia mengandungi – *Federal Gazettes – Peincipla Acts, Amending Acts Bills Supplement, (B) dan Gazette Notification (GN).* **State Gazettes** – State Legislations for Selangor, Pahang, Negeri Sembilan, Malacca, Johor, Terengganu, Perak, Penang, Perlis, Kedah, Kelantan dan Sarawak.
- iii). **Istilah Undang-undang (English – B. Malaysia)** – yang mengandungi lebih 30,000 perkataan, istilah dan frasa yang biasa digunakan oleh pengamal, peguam, pegawai kerajaan, pelajar serta mereka yang kerap terlibat dengan perundangan. Ia merupakan alat yang amat berguna terutamanya bagi mereka yang terlibat dengan kerja-kerja penterjemahan.
- iv). **Kamus Latin** – mengandungi lebih 5,000 perkataan. Ia dikompil daripada pelbagai sumber dan masih belum lengkap.
- v). **Judgements** – mengandungi *Privy Council Judgements* yang terpilih.
- vi). **Index of Subsidiary Legislations** – senarai lengkap *Legislative Supplement (A) [P.I.(A)]* dan *Legislative Supplements (B) [P.U.(B)]*.

Maklumat yang terkandung dalam pangkalan data dalam talian ini adalah komprehensif dan mudah untuk digunakan oleh pengguna sasaran seperti peguam, penasihat undang-undang, ahli akademik, pelajar undang-undang serta orang awam yang perlu merujuk kepada undang-undang Malaysia.

Perlu diingatkan bahawa langganan pangkalan data dalam talian ini adalah berdasarkan satu lesen sahaja, bermakna, cuma seorang individu sahaja yang boleh mengakses pangkalan data tersebut pada satu-satu masa.
